



**Robert Elliott Photography Ltd: terms and conditions**

It is mutually agreed that the following terms of agreement form the integral part of this contract and that no variation or modification of this contract shall be effective unless accepted by both parties in writing.

**Booking Fee:** A non-refundable deposit of £100 is required when the client signs this contract. Dates are only reserved when a deposit is paid by cheque ( payable to Robert Elliott Photography Ltd ) or in cash. The balance owing is due 14 days before the wedding date.

**Exclusivity:** Robert Elliott Photography Ltd will be the sole photographer retained for your day and will not book any other weddings on that day. Family and friends are permitted to take photographs as long as they do not disturb or interfere with photographer's duties. Guests are not permitted to take photographs of poses arranged by the photographer.

**Coverage:** Robert Elliott Photography Ltd cannot be held responsible for the lack of coverage caused by the bride, the groom, the wedding party or guests not being on time or interfering/restricting the photographer's duty. Although every effort will be made, Robert Elliott Photography Ltd does not undertake to guarantee any specific picture nor incorporate any specific background, location or group arrangement. Special requests are not binding instruction, although every effort is made to comply with the client's wishes.

**Weather Changes:** Weather permitting, the wedding photographs will be taken as agreed. In the event of any form of weather disturbances, Robert Elliott Photography Ltd will make the necessary changes in the photographic session and will not be responsible for any disappointment caused by adverse/unfavourable weather conditions. However, we will, with the co-operation of the client, do our best to produce agreed coverage of the wedding within the time allocated.

**Photographic Anomalies:** Owing to reflectance caused by a combination of certain dyes and materials, especially man made fibres, it is sometimes impossible to record the exact colour of a garment as seen by the human eye. The photographs will provide a pleasing colour balance based on flesh tones of the subject but cannot guarantee exact colour match.

**Force majeure:** In the unlikely event of partial or total photographic failure, injury or sickness beyond Robert Elliott Photography Ltd's control liability shall be limited to a full refund of all monies paid. Your statutory rights are not affected.

**Retouching:** Robert Elliott Photography Ltd may perform a standard amount of retouching on photographs at their discretion. Further retouching, digital manipulation and artist finishing is available to the client as an optional extra.

**Copyright:** the 1998 copyright, designs and patents act assigns copyright to Robert Elliott Photography Ltd. You may not copy the photographs taken under this contract, or allow copies to be made photographically, electronically or by any other means except without prior and written consent from Robert Elliott Photography Ltd. Robert Elliott Photography Ltd reserves the right to use your images for any form of advertising to promote their company. Web based promotions, brochures, galleries and competitions apply.

**Data Protection:** Your name and wedding details will be stored by Robert Elliott Photography Ltd on a private internal database and will not be made available to other companies or individuals. Should you wish to have your details removed from the database please advise Robert Elliott Photography Ltd in writing.
